<u>S3685A</u>	SAVINO -- Makes it a discriminatory practice for public employers to compensate employees of different sexes differently for work that is of comparable worth No Same as Comment: Labor Mandate
<u>S3785A</u>	LIBOUS -- Relates to impairments of health, presumption and staph/MRSA Same as A 6793 Comment: Health Mandate
<u>S4107</u>	STEWART-COUSINS -- Requires schools to provide instruction on the history of the Ukrainian genocide-holodomor of 1932 through 1933 Same as A 2755 Comment: Curriculum Mandate
<u>S4111</u>	STEWART-COUSINS -- Requires sanitation workers to receive certain training Same as A 1697 Comment: In Finance Committee as of 6/7/13 - Labor Mandate

<u>S4224</u>	MARCELLINO -- Enacts the healthy, safe and energy efficient outdoor lighting act to reduce harmful outdoor lighting Same as A 751 Comment: Mandate

<u>S4524A</u>	FUSCHILLO -- Requires schools to provide instruction in cardiopulmonary resuscitation No Same as Comment: Curriculum Mandate
<u>S4569</u>	HOYLMAN -- Restricts the distribution of students' personally identifying information and directs the commissioner of education to develop appropriate regulations regarding permitted disclosure of such information No Same as Comment: Mandate
<u>S4876</u>	GOLDEN -- Requires newly certified teachers to be trained in the use of an epinephrine auto-injector; to be certified within 3 months of date of hire Same as A 759-A Comment: Health Mandate
<u>S4908</u>	GOLDEN -- Makes permanent the provisions of the civil service law relating to public arbitration of disputes between public employers and employee organizations; repealer Same as A 6714 Comment: Labor Mandate
<u>S4909</u>	GOLDEN -- Extends the effectiveness of provisions of the civil service law relating to injunctive relief in improper practice cases Same as A 6869 Comment: Labor Mandate

<u>S5072</u>	BONACIC -- Relates to certain notices of claims, pleading an affirmative defense and making a motion to dismiss Same as A 6550 Comment: Judiciary Mandate

<u>S5336</u>	SAVINO -- Exempts parties liable for failure to obey or enforce domestic violence orders of protection or temporary orders of protection from limited liability provisions Same as A 1395 Comment: Judiciary Mandate

<u>A6574</u>	Abbate -- Relates to suspension or demotion upon the abolition or reduction of positions for labor class and noncompetitive titles; repealer No Same as Comment: Labor Mandate
<u>A6581</u>	Abbate -- Grants employees in labor class positions rights with regards to the suspension or demotion upon abolition or reduction of certain positions No Same as Comment: Labor Mandate
